BRANCHES REOPEN TO ENHANCE SERVICE TO MEMBERS

American Heritage Credit Union reopened its branch lobbies on Saturday, June 6, 2020, as Philadelphia, Bucks and Montgomery Counties, as well as New Jersey, eased multiple COVID-19 stay-at-home orders.

In adherence to state and CDC guidelines, facemasks are required, and social distancing guidelines will be in effect. We encourage appointments for lobby services such as account opening, IRA services or business services. Shared Branching (non-member) is temporarily suspended.

Members are encouraged to continue using online services and remote account access technologies, as well as the drive-thru, to limit contact with staff and other members.

THIRTY CECELIA B. GRADY COLLEGE SCHOLARSHIPS AWARDED

Finally, we have some milestones to celebrate - we recently reached \$3 billion in assets and welcomed our 200,000th member! We are blessed to have a membership that truly represents the wonderful diversity of our community, and just as importantly, that exemplifies people helping people better than any financial institution in the country!

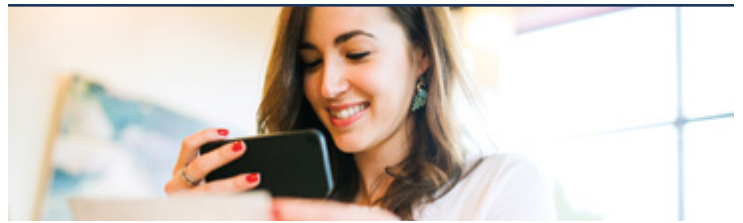

PHONE TELLER SYSTEM UPDATE

American Heritage will be Converting the Phone Teller System on July 20, 2020. In the next couple of weeks, members will be offered an option to preview the new Smart Teller system, before the decommissioning of our current system in July.
